D. DISCRIMINATION STATEMENT			
<p>I believe I have been discriminated against pursuant to Florida Statute, Chapter 509/760 for the following reason(s):</p> <p>The following statement is supporting information to support his allegations following up to his most recent date of harm: The complainant (CP) was playing poker on 05/19/2018. One of the poker opponents called him a "ni**er" CP was upset and told the opponent not to call him that. They began to argue, and the poker dealer called the supervisor. The poker dealer said the "black guy" and pointed his finger at CP; he was upset because an unknown white male called him a "ni**er." CP was instructed to leave and vacate the premises; he complied. CP returned the next day and played poker and watched a dog race. After two hours of playing poker CP was escorted to the security office to retrieve some property he had left behind the day before. CP was told to sign a document after he signed the slip papers. They told him he could not come back and had to call in 60 days to reinstate. After 60 days, CP called Respondent, and they told him no because he filed a lawsuit against them.</p> <p>CP believes he was discriminated against due to his skin color and country of origin. CP states that Respondent only banned him and not the white person who called him a n**er but allowed the white person to continue playing. On or around November 2021, CP called and spoke with Sandy, the poker manager, and she stated she has no objection to CP coming back and playing. However, CP would have to speak to Security Chief, kens Jones. Kens Jones said he would not let him come back; Due to numerous lawsuits and complaints, CP filed against Respondent.
